Trolley Expands service to Marriott and Hilton Linking downtown Napa with Bel Aire Plaza and hotels

Napa, California The downtown Napa Trolley has extended service to northwest Napa delivering riders directly from the Marriott and Hilton hotels, Bel Aire Plaza, several B&B's and other locations to historic downtown Napa.

Trips originating in the downtown Napa free zone are still a *free ride*. Effective Wednesday, September 3, 2008 the fare for trips originating outside of the free zone are 60-cents to \$1.25. The Trolley operates from 11 am to 9:46 pm daily with longer hours until 10:55 pm on Friday and Saturday night.
